



## Dog Licensing Information

If your dog's rabies shot expires before November 1, 2016, you must get your dog a new rabies shot before we can release your 2016 dog license to you.

*Proof of Rabies Inoculation is required for issuance of a license and registration tag; Rabies Vaccination Requirement: N.J.S.A. 4:19-15-3a required that the duration of the immunity extends throughout at least the first ten (10) months of the twelve (12) month licensing period.*

If your dog has been spayed or neutered, the dog license fee is \$12.00. If your dog has not been spayed or neutered, the dog license fee is \$15.00. A person applying for a dog license and registration tag shall pay a fixed fee which includes the sum of one (\$1.00) dollar for the registration tag; twenty (\$0.20) cents for the Department of Health of the State of New Jersey Pilot Client Fund and a three (\$3.00) dollars additional surcharge on all licenses issued for non-spayed and non-neutered dogs to the State Treasurer for the Animal Population Control Fund. Owners presenting a certificate signed by a licensed veterinarian certifying that their dog has been spayed or neutered are exempt from the three (\$3.00) dollar surcharge.


**Registration tags and renewals thereof shall expire on January 31<sup>st</sup> of each year. A late fee of five (\$5.00) dollars shall be assessed if a renewal fee is paid after March 31<sup>st</sup>.**

You may obtain your cat license either by mail or in person at the Sea Girt Borough Hall, 321 Baltimore Boulevard, Sea Girt, NJ.

Please make checks payable to Sea Girt Borough and include a self address envelope. You must include Proof of Rabies Vaccination. If your cat has been spayed or neutered, you must also include this proof with your application.
